# What are "home health care services"?

Home health care services are services based on nursing and rehabilitative assistance delivered by the competent local health organization (in France and Belgium it is named soins à domicile, in Austria hauskrankenpflege, in Great Britain district nursing, in Spain asistencia sociosanitaria domiciliaria, in Italy assistenza domiciliare integrata, etc.).

## The project target

The project target are Home Care formal services (both Home Assistance and Home Health Care services), provided by public organizations or by private organizations on the basis of protocols and contracts with the public sector, targeted to non self sufficient individuals aged sixty-five and over (in particular seventy-five and over), including:

- informal care given by a person receiving regular payment and/ or skills training;
- respite services to the family/ caregiver.

### The project operational aims

In the detailed project presented, main and secondary objectives were defined according to the Guidelines of the Lisbon Agenda, including both overall objectives and specific purposes.

In a more precise way we can define our operational **objectives** as follows:

- improving the knowledge base and the exchange of information about the Home Care Systems in each Country Partner;
- disseminating and transferring across the countries existing best practices of quality assessment in Home Care;
- developing a set of monitoring, assessment and performance indicators on quality delivered in Home Care.

## The project results

The project sets out to achieve the following results:

- a comparative analysis of sociodemographic trends and the evolutions of elderly health conditions in every single country and area of the project partners;
- an analysis of the European, national and regional legislation about long

- term care policies, in particular for what concerns Home Care systems;
- a transnational album of good practices and guidelines for monitoring and assessment in Home Care services:
- a set of efficacy and effectiveness indicators for monitoring quality in Home Care:
- an analytical final research report on the overall results of the research activities:
- a promotion of the project results and dissemination of good practices collected through different mainstreaming actions.
